IMPORTANT INFORMATION FOR THE SUMMONS REQUESTOR

- To summons a witness to a hearing, you must complete this Summons to a Witness form and file it with the Horse Racing Appeal Panel (HRAP) for signature.
- Incomplete or illegible forms may result in a summons request being denied.
- **Service of a summons on a witness is the responsibility of the party who obtained the summons.** For service to be effective, it must meet the requirements of Rule 5, (a) and (f), Service and Filing, of the Rules of Procedure.
- The party obtaining the summons shall pay the witness' fees and allowances in accordance with Tariff A

Subsections 11(1) and (2) of the *Statutory Powers Procedure Act*, R.S.O. 1990, c. S.22 as amended provide as follows:

1. A witness at an oral or electronic hearing is entitled to be advised by a representative as to his or her rights, but such representative may take no other part in the hearing without leave of the Panel.

2. Where an oral hearing is closed to the public, the witness's representative is not entitled to be present except when that witness is giving evidence.

IMPORTANT INFORMATION FOR THE WITNESS BEING SUMMONED

- A summons to witness must be served upon you personally.
- You are entitled to be paid witness' fees and allowances in accordance with Tariff A under the Rules of Civil Procedure.
- If you fail to attend and give evidence at the hearing, or to produce the documents or things specified, at the time and place specified, without lawful excuse, you are liable to punishment by the Superior Court of Justice in the same manner as if for contempt of that court for disobedience of a subpoena.
- If you require accommodation under the Human Rights Code to participate in the hearing as required, contact the HRAP office at 416-326-8700.
